Most recently, she served as Division Director of Gynecologic Oncology at the George Washington Cancer Center, where she also held an academic appointment as Associate Professor of Obstetrics and Gynecology at George Washington University School of Medicine and Health Sciences. She has led and worked in gynecologic oncology programs across several military medical centers, including Walter Reed National Military Medical Center, San Antonio Military Medical Center, and Brooke Army Medical Center and served as Associate Program Director of the National Capital Consortium Gynecologic Oncology Fellowship Program at Walter Reed National Military Medical Center. An accomplished clinical researcher, Dr. Chappell has activated several cooperative NRG clinical trials, published on surgical quality work, health disparities, and molecular predictors in gynecologic cancers.

Dr. Chappell earned her medical degree from Boston University School of Medicine. She completed residency training in Obstetrics and Gynecology at Boston Medical Center before pursuing fellowship training in Gynecologic Oncology through the National Capital Consortium at the Uniformed Services University/Walter Reed National Military Medical Center. She is board-certified in Gynecologic Oncology by the American Board of Obstetrics and Gynecology and is a Fellow of both the American College of Obstetricians and Gynecologists and the American College of Surgeons. Dr. Chappell is also serving on the patient education committee of the Foundation for Women's Cancer and is an active member of the Society of Gynecologic Oncology.
