The <u>Scientific Registry of Transplant Recipients (SRTR)</u>, <u>July 2025 report</u> recognized the BILH Heart Transplant Program's outstanding outcomes. The program is currently ranked first in the US, measuring above the national average in all major metrics, including survival on the waitlist, access to transplant faster, and one-year survival outcomes.



Firefighter Health Screening Program
