Jennifer Ho, MD, has been promoted to **Professor of Medicine** at **Harvard Medical School**. Dr. Ho is the Harrison Family Endowed Chair in Cardiovascular Research, Director of Research in the **Division of Cardiovascular Medicine**, faculty member of the advanced heart failure and heart transplantation section at BIDMC, and Associate Member of the Broad Institute at Harvard and MIT. She is an internationally recognized physician-scientist conducting clinical and patient-oriented translational research to understand mechanisms driving obesity-related cardiovascular disease with a focus on heart failure with preserved ejection fraction (HFpEF). Her lab has been continuously NIH funded, she has published over 175 peer-reviewed original investigations, and she directs the Cardiovascular T32 training grant at BIDMC. Dr. Ho has been instrumental in her role as Director of Research, working to create the right environment and opportunities to engage talented people across different research and clinical disciplines. Her selfless dedication to patients, trainees, and her peers is deeply admired – and elevates our work across all our missions.

Catherine DesRoches, DrPH, MSc

Catherine (Cait) M. DesRoches, DrPH, MSc, faculty in the **Division of General Medicine** research section and Program Director of OpenNotes, has been appointed the **John F. Keane & Family Associate Professor of Medicine at Harvard Medical School**. The Keane Chair was established to promote patient engagement, safety, and healthcare value through fully transparent communication among patients, families, and clinicians — a mission at the heart of Dr. DesRoches's career. Dr. DesRoches is Associate Professor of Medicine at Harvard Medical School and a distinguished health services researcher with expertise in emerging trends in healthcare delivery. Under her leadership, OpenNotes has grown from a research initiative into a federally mandated standard of care: following the 21st Century Cures Act and the 2021 Information Blocking Rule, all electronic health information must now be made available to patients – a transformation to which Dr. DesRoches's work contributed directly. In accepting the chair, Dr. DesRoches follows its inaugural incumbent, OpenNotes co-founder Dr. Tom Delbanco – a fitting continuation of the legacy of scholarship and patient-centered innovation that the Keane Chair was created to advance.
